WILEY HALL WAS CONSTRUCTED IN 1898 AND CURRENTLY SERVES AS CLASSROOMS AND OFFICES FOR THE BUSINESS ADMINISTRATION FACULTY. THE GENERAL'S HOUSE WAS CONSTRUCTED BETWEEN 1887 AND 1891 AND ORIGINALLY SERVED AS THE HOME FOR
